EXECUTIVE BOARD MEETING HELD ON 4 MARCH 2010

97. CHILDCARE CAPITAL FUNDING

The Board received a report of the Strategic Director, Children and Young People on childcare capital funding 2009/11.

The report detailed the level and source of funding, funding criteria, the bidding process and also gave details of the proposed allocation of funding in the 2010/11 financial year.

The Board noted that capital funding had been allocated from the Department for Children and Families, to enable the provision of free early education introduced by the Early Years Foundation Stage (EYFS) in 2008. The grant had three main aims:-

to improve the quality of the learning environment in early years settings, providing free entitlement, to support delivery of the EYFS, with a particular emphasis on improving play and physical activities and ICT resources;

to ensure all children, including disabled children, were able to access provision; and

to enable private, voluntary and independent providers to deliver the extension to the free offer for 3 and 4 year olds and to do so flexibly.

Members discussed the details of the Childcare Capital spend detailed in Appendix 1, attached to the report. It was agreed that this information should be included in the Authority's report to Governing Bodies.

RESOLVED: That

- (1) the proposed allocation of Childcare Capital Funding for ICT equipment be approved; and
- (2) the proposed allocation of Childcare Capital Funding for capital repairs and/ or development/equipment be

approved.

EXECUTIVE BOARD MEETING HELD ON 8 APRIL 2010

103. SCHOOL ADMISSIONS ARRANGEMENTS 2011-KEY DECISION

The Board considered a report of the Strategic Director, Children and Young People which set out the fulfilment of the requirement under the School Standards and Framework Act 1998, the Education Act 2002, the Education and Inspections Act, 2006 and associated regulations, to determine Halton Local Authority's (LAs) School Admissions Policy for LA maintained community and voluntary controlled schools, and co-ordinated admission schemes for all primary and secondary schools for September 2011 following statutory consultation.

It was noted that the LA also consulted on the admission arrangements to its maintained nursery schools for the September 2011 intake.

Members were advised that the Government now required Local Authorities to manage the In-Year Admissions process for children moving between schools during the academic year from September 2010 onwards and the consultation paper was issued alongside the above consultation paper seeking views on an appropriate model.

It was further noted that in January 2010 a statutory required consultation paper on the proposed admission arrangements and coordinated admission schemes for the September 2011 intake was issued. A copy of this consultation was appended to the report for information. The consultation procedure undertaken was outlined in the report, together with information regarding implications for policies and the Council's priorities.

The Board discussed the sensitivity issues encountered during the admission process. There was a slight spike in population of school children, in terms of admissions, this year which was expected to reduce next. Concerns were raised over children having to travel further to attend schools. In response it was noted that as parents accepted or declined places, nearer school places may become available for some children. Out of a total 3500 preferences only 13 had raised concerns.

REASONS FOR DECISION

The decision was statutorily required and any revision to the proposed arrangements may adversely affect school place planning as detailed in 7.1 of the report.

ALTERNATIVE OPTIONS CONSIDERED AND REJECTED

Other options considered and rejected included the allocation of places through random allocation (lottery) as this method could be seen as arbitrary and random.

IMPLEMENTATION DATE

The Policy allied for the September 2011 academic intake and would apply for three years unless further central of local government changes were required.

RESOLVED: That

- 1) the Board approves the School Admissions Policy Admission Arrangements and co-ordinated schemes for admission to primary and secondary schools for the 2011/12 academic year; and
- 2) the Board approves the adoption of the In-Year Co-ordinated Admissions Scheme as statutorily required for September 2010 onwards.

(NB: Councillor Nelson declared a personal interest in the following item due to being the Chair of Governors for the Grange School).

104. PRIMARY SEN UNIT REVIEW - KEY DECISION

The Board received a report of the Strategic Director, Children and Young People which summarised the response to the statutory consultation undertaken on Primary Special Education Unit (SEN) Provision in Halton. An outline of the decision making process was included in the report for information.

Members were advised that the review of SEN units resulted in a set of proposals designed to provide flexible provision within mainstream schools that allowed pupils to spend as much time as possible learning alongside their peers, depending on their individual needs.

It was noted that consultation took place in March 2009 and the feedback from the initial consultation had led to revised proposals with a second round of consultation in June 2009 after approval to commence consultation on the revised proposals which was given by Executive Board in 2009. Detailed in the report for information were the provisions that were proposed. The consultation procedure undertaken was outlined in the

report in addition to a copy of the statutory notice and proposal for information.

It was reported that there had been 137 responses to the formal consultation with 135 responses in support of the proposals published in the statutory notice.

Members were advised that the decision maker (Executive Board) must decide the proposals within two months of the end of the representation period otherwise the decision must be referred to the adjudicator for a decision. Appended to the report for information were details of the issues the decision maker needed to consider.

The report also set out the proposals in detail for each school that would be affected by the proposals.

The Board noted that all parties involved had been consulted despite reports in the local press to the contrary. Members discussed and welcomed the increased provision set out in the review.

REASONS FOR DECISION

To enable the process to be completed within statutory timescales. Decision to proceed to implementation must be made within two months of the end of the formal consultation.

Mainstream Primary SEN units are not matching the present and future requirements of the Borough. At present, there are surplus places within Primary mainstream SEN units.

ALTERNATIVE OPTIONS CONSIDERED AND REJECTED

To leave provision as it is. This would leave vulnerable to challenge on the basis of need and value for money.

IMPLEMENTATION DATE

Approval to proceed with the proposals for primary SEN unit provision must be agreed within two months of the end of the six weeks statutory notice period (21st April 2010). Implementation in September 2011 to be in line with the implementation of the agreed Secondary resourced provision.

RESOLVED: That

1) to receive the report on the proposals for Primary SEN Unit

provision; and

2) to approve the proposals, in line with the response to the formal consultation, within the statutory timescale of two months from the end of the representation period (deadline 24th April 2010).

105. <u>SCHOOL ORGANISATION - THE HEATH A SPECIALIST</u> TECHNOLOGY COLLEGE- KEY DECISION

The Board considered a report of the Strategic Director, Children and Young People which set out the response to the statutory consultation to make a prescribed alteration to expand The Heath A Specialist Technology College from 1st September 2013 so that it could offer 1350 with a proposed published admission number of 270. It was noted the report also sought a decision from the Board on the proposal.

Members were advised that during the consultation on future secondary provision in Halton, it was agreed that The Heath Specialist Technology College be expanded so that once the BSF building work had been completed the school would provide 270 places per year with a total of 1350 places for 11 – 16 year olds.

Detailed in the report were the aims of the proposals to expand the size of The Heath Specialist School. The consultation procedure undertaken was outlined in the report in addition to the details of the 63 responses which had been received.

Members were advised that the fourth bullet point in paragraph 3.2 of the report should have read as follows: Reduce the number of pupils choosing to access secondary education <u>outside</u> the borough.

It was further noted that the decision maker (Executive Board) must decide the proposal within two months of the end of the representation period otherwise the decision must be referred to the Adjudicator for a decision. Appended to the report was a copy of the statutory proposal details of the consultation and the issues the decision maker needed to consider. It was also noted that the decision must be given whether it was approved or rejected and should include the factors and criteria for the decision. Details of who copies of the decision must be sent to were outlined in the report.

REASON FOR DECISION

To provide more choice and diversity and retain pupils within the Borough.

ALTERNATIVE OPTIONS CONSIDERED AND REJECTED

N/A.

IMPLEMENTATION DATE

The decision needed to be made by 1st May 2010.

RESOLVED: That

- the school be enlarged, as part of the Halton BSF programme and The Heath School be rebuilt and refurbished; and
- 2) the proposed capacity of the school will increase to 1350 from 1st September 2013 and the proposed admission number increased to 270.

106. <u>COMMISSIONING OF POST 16 PROVISION IN HALTON- KEY</u> DECISION

The Board received a report of the Strategic Director, Children and Young People which informed members of the abolition of the Learning and Skills Council (LSC) under the Apprenticeship Skills Children and Learning Bill (ACSL) and transfer of statutory duty and powers to Local Authorities from April 2010.

It was reported that on 1st April 2010, the LSC would be abolished and all functions previously carried out by the LSC with respect to 16 – 19 education and training would transfer either to local authorities or the Young People's Learning Agency (YPLA). A number of brand new duties and powers for local authorities would be created.

It was noted that local authorities would have the central commissioning role for all education and training for young people aged 16 – 19 and up to the age of 25 for those with learning difficulties, and for those people in youth custody aged 10 to 18.

Members were advised that the Strategic Director for Children and Young People had now assumed lead commissioning responsibility for Post 16 Education and Training in the Borough and sat on the Riverside College Board which was the major provider of post 16 education in Halton. It was noted that this would not be appropriate from 1st April 2010 when the Council would assume statutory commissioning responsibility due to

inherent conflict of interest. The role was recommended to go to the Operational Director – Employment, Economic Regeneration and Business Development. This would be subject to a suitability interview by Riverside College Board.

Appended to the report for information were the key responsibilities for partners who were central to the commissioning process. The transferred LSC posts and resources would be fully funded through a Special Purposes Grant along with a contribution towards non employment costs would be made. Key documents that had been published that would support the transition were referred to in the report.

It was further reported that the 14 - 19 reform programme was a substantial element of the transfer. Details of this transfer were outlined in the report for information.

Members were further informed of the transition from the LSC to the Skills Funding Agency (SFA) which would be established to take on the post 19 functions of the LSC. It was reported that the SFA would route around £3.5 billion of funding to further education colleges and other providers including the Third Sector, primarily in response to customer (employer and learner) choice on programmes such as Train to Gain. It was further noted that the SFA would operate through three customer focused gateways which were outlined in the report for information.

The report also set out the Delivery Plan, policy implications and commissioning details.

The Board discussed the amount of funding provided to ensure every young person was engaged in training or education in terms of whether it was a sufficient amount. In reply it was noted that the provisions and progress would be monitored closely by the Council.

REASONS FOR DECISION

Council assumes responsibility for commissioning of post 16 provision from 1st April 2010. Through commissioning the Council would be able to ensure that a broad range of high quality 14 – 19 pathways was available for all young people. The Strategic Director for Children's Services would be the lead commissioner of provision, therefore could not sit on Riverside College Board.

ALTERNATIVE OPTIONS CONSIDERED AND REJECTED

Statutory Responsibility therefore no other options available.

IMPLEMENTATION DATE

1st April 2010.

RESOLVED: That the Council

- 1) assumes responsibility for commissioning of post 16 provision with effect form 1st April 2010;
- 2) receives LSC staff under TUPE regulations to support post 16 commissioning;
- 3) ensures a holistic approach to planning by reporting on post 16 commissioning to the Local Strategic Partnership and Employment Learning and Skills Strategic Partnership;
- 4) Executive Board receives a report as part of the annual commissioning cycle for post 16 education and training; and
- 5) replaces the Strategic Director for Children and Young People with Operational Director for Employment, Economic Regeneration and Business on Riverside College Governing body.

107. PLAYBUILDER PROJECT

The Board considered a report of the Strategic Director, Children and Young People which recognised the significant contribution that the Playbuilder Project had made in respect of National Indicator N199.

It was noted that 13 play areas had been delivered over the first two years of the scheme, details of which were outlined in the report for information, and considerable positive feedback had been received.

The proposed 9 sites for 2010/11 were set out in the report for consideration. Members were advised that successful delivery of the Playbuilder project would make a significant contribution to embed play in local policy in particular to National Indicator N199 (Satisfaction with Outdoor Play Facilities).

Arising from the discussion it was noted that the Tell Us Survey had reported a 10% increase in satisfaction levels and the Board wished to note its thanks to the team from the Children and Young People Directorate and broader Council involved in developing the sites and innovative new designs of the play areas and the positive effect they have had on the

Borough.

REASONS FOR DECISION

To agree (8) projects to be progressed in Playbuilder Project year 3.

"I always like to start by looking back over the business conducted by the board during the previous twelve months. One of the first things that struck me was the large amount of time we had spent during that period looking more closely at our strategies and policies for our Children in Care.

In June 2009 members of the board were trained and encouraged to take part in inspection of our care homes (Regulation 33 visits) and also to meet with our social workers and their managers (Climbié visits) to make sure that they are fully supported in carrying out their work in protecting and helping children and young people. In September 2009 Climbié visits were a specific focus and in January 2010 a full review of our placement strategy for our Children in Care was conducted.

This increased scrutiny is only right and proper as over the last few years we have heard of Councils failing children by not providing adequate social care services. We can never be too careful when working with our most vulnerable and needy.

Once again the educational attainment of our children and young people was outstanding. I would like to take this opportunity to congratulate our students who did so well, and also thank the parents, carers and teachers who supported them in achieving these fantastic results. The results show Halton's commitment to drive up standards and improve the opportunities available to all of our young people as they move into adulthood.

Progress continued on the Building Schools for the Future (BSF) programme. This programme will transform Halton's Secondary Education provision through the investment of up to £100 million into our Secondary Schools. BSF and the Primary Capital programme, which will look at our Primary Schools, are massive commitments into the future of education in Halton. Their success, as well as tackling some of the entrenched health issues facing our children and young people are some of the main challenges facing the authority and it's partners.

Once again as part of the function of overview and scrutiny to hold the Executive Board to account we held the fourth of our annual question and answer sessions with a member of the Executive Board; this time it was the turn of Councillor Tom McInerney, Executive Portfolio Holder for the Children and Young People, who talked and answered questions on the future initiatives for the young people of our Borough.

Looking back I think it has been a good fourth year for the board and I would like to thank all of the members of the board, as well as all of the officers involved for their continued support and contribution.

Finally, I would like to conclude this report by thanking all of the officers and members (of all parties) involved in all of the 'additional duties' that take place to make sure that the children and young people receive that best care and support. Duties such as being a school governor with all of the responsibilities that that entails, statutory inspections of our care homes (Regulation 33) or of our social worker teams (Climbié visits), membership of the Local Safeguarding Board, the Adoptions Panel, the Children and Young People's Alliance Board, to name but a few of the 'extra duties' that both members and officers perform to support and improve the lives of the children and young people of our Borough."

MEMBERSHIP AND RESPONSIBILITIES

During 2009/10 the Board comprised eleven Councillors – Cllr M Dennett (Chairman), Cllr M Horabin (Vice Chairman), Cllr P Browne, Cllr P Drakeley, Cllr K Loftus, Cllr R Gilligan, Cllr T Higginson, Cllr J Lowe, Cllr S Parker, Cllr M Ratcliffe, Cllr J Stockton.

The Board is responsible for scrutinising performance and formulating policy in relation to the work of the Council (and its partner agencies within Children's Trust Arrangements) in seeking: to ensure that children and young people in Halton have the best possible start in life and opportunities to fulfil their potential and succeed; and to scrutinise progress against the Corporate Plan and the Children and Young People's Plan.

REVIEW OF THE YEAR

The full Board met five times during the year, and set out below are some of the main initiatives that the Board has worked on during the year.

Educational Attainment and Achievement 2009

School performance was discussed in relation to the successes specifically at Key Stage 2 and 4 and also in terms of progress in narrowing the gap for achievement for vulnerable pupils including those with special educational needs. Halton continues to perform well in comparison to national outcomes as a result of the gains made and maintained over the past few years.

Services for Homeless Young People

Consultation meetings with homeless young people in Halton took place to raise issues and make suggestions which could have a positive impact on the quality of life of homeless young people, if implemented. Members noted the two key issues identified from the consultation meetings. The Board considered what training provision was already available through YMCA tailored training and Riverside College short courses and requested that a proposal for funding for costs of public transport be submitted to the 14-19 Partnership.

Placement Strategy Review

A review of the current position regarding the Halton Children In Care (CIC) population and the arrangements for placing children was undertaken. Members noted that there had been significant difficulty in recent years in recruiting Foster Carers to meet demand for placements and to provide a choice of placement. Members noted that the recent Ofsted inspection of the Foster Care Service in Halton judged the service to be good with some outstanding features, however, the Inspector had made a formal recommendation in respect of National Minimum Standard 17. The Board considered the barriers to the recruitment of foster carers and how these had been addressed in the review.

Service Plans

This year the Board continued to take significant steps forward in the way it engaged with the service planning process. The PPB Members identified issues and activities they hoped could be prioritised in the service plans for 20010/11-2012/3.

Developments for Young Carers

National and Local Developments for Young Carers were set out for Members consideration including the new locality structure, family centred approaches to early intervention and prevention for Children In Need. Members felt that these developments were worthy of further work and therefore 'Young Carers' was agreed as a scrutiny topic for the Board's 2010/11 work programme.

Developments in Post 16 Provision

The transfer of statutory responsibility for 16-19 provision to local authorities was due to take place in 2013 and the Board received a progress report on the work undertaken to date. Members considered the 14-19 Education Plan, partner involvement and how commissioning and financial systems would operate. A particular concern of the Board was transportation between sites and what provision would be available.

PERFORMANCE ISSUES

2009/10 saw the important, high level outcomes for children and young people in Halton coming more under the scrutiny spotlight. The PPB raised its sights to focus attention on key, strategic indicators of performance e.g. as set out in the Local Area Agreement and in the service's work with partners. Through the LAA a suite of targets was agreed for Halton with Government and local partners. It emphasises the requirement for named partners to co-operate in striving to achieve those targets. There were 34 indicators in the LAA, together with statutory education and early years targets. The LAA reflects the priorities in Halton's community strategy for improving the quality of life in Halton, including the need to tackle high teenage pregnancy rates in the Borough.

RESTRUCTURING OF THE CYPD

The Council's efficiency programme has resulted in a restructuring of the Children and Young People's Directorate to be implemented from 1st April 2010. The CYP Directorate will reduce from four Departments to three:

- Children and Families Services
- Learning and Achievement Services
- Children's Organisation and Provision

The Children's Safeguarding Unit will report directly to the Strategic Director in order to separate the delivery of Safeguarding Services from a review and auditing function.

WORK PROGRAMME FOR 20010/11

The Board has decided that during the current municipal year (2010/11) it will carry out Topic reviews examining the following area:

Young Carers

This topic area will be completed in 2010/11.

Health of Young People

SUBJECT: Children in Need Referral and Assessment

Analysis

WARD(S) Borough-wide

1.0 PURPOSE OF THE REPORT

- 1.1 The purpose of this report is to afford Members the opportunity to scrutinise Referral and Assessment activity and advise of issues impacting on current performance within Children in Need (CiN) service.
- 1.2 The completion of Initial and Core Assessments within timescales stands at 76.2% for Initial Assessments and 80.3% for Core Assessments. This Data has not been quality assured and is currently subject to a 'data tidy' exercise.
- 1.3 It is important that Members have a good understanding of the reason for this performance and are satisfied that adequate strategies are in place to ensure that the children of Halton are safeguarded. Recent Ofsted inspections of Contact, Referral and Assessment processes in other Local authorities have looked at scrutiny of safeguarding practices.

2.0 RECOMMENDATION: That

- (1) the PPB note the contents of the report;
- (2) Halton Safeguarding Children Board continues to scrutinise and support the work of the Children's Trust in relation to the development of Localities and the progress of the CAF Action Plan;
- (3) Halton safeguarding Children Board scrutinises the response to Domestic Violence across the levels of need within Halton; and
- (4) a further report is presented to PPB in six months.

3.0 SUPPORTING INFORMATION

- 3.1 The recent CAF review highlighted issues on the role of early intervention and meeting the needs of children at the earliest possible point. This is within a context of increasing referrals to Children's Social Care (CSC).
- 3.2 The role of Team Around the Family (Locality Working) with emphasis on the CAF plus model and robust and early intervention should go some way to address some of these issues but it will be some time before there is an impact on referrals and caseloads within CiN.
- 3.3 Children's Social Care is made up of a number of services. The CiN service provides contact referral and assessment services to Children in need and those in need of protection. The Permanence team provides services to children in care who have a plan of permanence and the Young People's team provides services to care leavers and Children in Need who are 16+. The Children with Disability Team provides services for those children with complex needs. The fostering team and adoption team undertake family finding and recruitment of carers.

3.4 Analysis

Referrals

A referral is a request to Children's Social Care for a service or advice that is accepted by Children's Social Care for allocation for assessment.

- In the seven months June to January there was a total of 842 referrals. The total number of referrals for 08/09 was 1324.
- There appear to be peaks around main school holiday times,
 June July and August and again in December.
- Police generated 349 or 41.4 % of referrals via the CAVA notification process.
- The main reasons for referral were Family Dysfunction, 36%(303), Domestic Abuse 26%(221) and Neglect 16%(133).
- Only 7.2% or 61 of the 849, referrals received had previously had a CAF. This does not support the argument that the rise in referrals is due to improved identification of need.
- 138 of the 842 referrals to CSC closed within 3 months or 16.4%

3.5 Contacts

A contact is a request to Children's Social Care for a service or advice that is not accepted for allocation for assessment as it does not meet the criteria for access to assessment at Levels 3a, 3b and 4 of Halton's Level of Need Criteria.

 There were a further 408 contacts during the period. 160 of those contacts were notifications form organisations such as CAFCASS, probation, Ofsted etc, all generating work in terms of Carefirst checks, responding to enquiry and loading on the system.

3.6 Caseloads

- The total number of open cases in CiN as of 31st January 10 was 668
- The three additional social work posts agreed following the review of Safeguarding Services in light of Baby P in Haringay have now been appointed to and will shortly be in post.
- Below is a table of social worker case Loads within CiN as of 31st January 10. A Caseload management tool has been developed to aid discussion in supervision about caseloads and assist in understanding the workload for individual workers.

 Despite the increase in Referrals the vast majority of cases are managed on a CiN basis and overall Child Protection (CP) Plan numbers and Children in Care (CiC) numbers have remained stable at 80 -85 and 155 respectively.

3.7 Court Activity

Court activity also impacts significantly on the work of the CiN teams. In January 10 there were 25 sets of Care proceedings compared to the usual average of 16 -17. This is not due to an increase in issuing of proceedings but reflects the difficulties in the courts at the present time. The average length of proceedings during this period was 49 weeks.

3.8 Capacity

- Management capacity for CiN Service has been an issue. We
 will shortly have four Practice Managers and one Principal
 Manager vacancy. As well as pressure in terms of
 supervision points this also creates pressure in respect of
 authorising of assessments and other critical reports and
 documentation and the chairing of key meetings including
 Core Groups and CiC planning meetings.
- In order to address this shortfall, appropriate measures have been put in place.
- The Recruitment and Retention strategy has recently been reviewed and revised with increased focus on management capacity. We have recently advertised and recruited to vacant management posts with both internal and external appointments. This will mean that providing all posts are accepted, we will only have on vacant Practice Manager post in Children in Need. This round of recruitment has been successful due to the positive outcome of the recent Job

Evaluation appeal and agreement that Principal and Practice Managers salaries will attract a market supplement to ensure that Halton remain competitive with neighbouring authorities. This shortage of management capacity reflects the national picture.

- Halton is committed to developing a 'grow your own' traineeship for social workers who are aspiring managers, building o the success of social work traineeship and student intake scheme. The Children's workforce Development Council is developing management programs which Halton have signed up to.
- The recruitment and retention of social workers remains good in Halton.
- The Divisional Manager CiN is meeting with Principal Managers fortnightly to focus on performance issues.

3.8 Performance / Data

- Considerable time is currently spent on 'data tidy up'. This is exacerbated by the three systems that Social workers currently have to operate, Carefirst, Integrated Children's System (ICS) and paper files. Most information has to be inputted at least twice on two separate systems.
- Carefirst 6 and Electronic Social Care Records should help to resolve these issues but they are some way off. Social Workers are involved in the design of Carefirst 6 and whilst it is important that this is progressed speedily this needs to be balanced against ensuring we get it right.
- It would be helpful to bring forward the roll out of mobile working (lap tops with 3 G cards) for all social workers to provide greater flexibility around completion of assessments.

3.9 Summary

Whilst there is considerable pressure within the children in need teams, it must be emphasised that whilst there may be problems and delays in the recording of assessment processes, all children are seen within seven days of referral. Assessments are generally of a high standard and this has been confirmed through the Case File Audit Process.

The numbers of Children in Care and Children subject to a Child Protection Plan remain stable and there is evidence of robust safeguarding and care planning processes. There are no unallocated cases.

The roll out of Team around the Family (Locality working: see separate report) with an emphasis on CAF plus model should help to reduce the number of referrals to Children's Social Care. There is a commitment to providing experienced social workers for the Locality Teams to establish a 'Triage' approach to referrals.

4.0 POLICY IMPLICATIONS

4.1 The work of the Children in Need teams is underpinned by Working Together 2010, the main purpose to provide services to the most vulnerable children including those in need of protection. This is a statutory function that is measured through a series of national Indicators. The performance of these teams impacts on all aspects of Children's Social Care and it is essential that we ensure that our safeguarding processes through the duty referral and assessment process remain robust.

5.0 OTHER IMPLICATIONS

5.1 The CiN teams have just experienced their first Ofsted Unannounced inspection, which can have an impact on the Council's overall rating. Whilst this report highlights some of the current difficulties and constraints it is important to emphasise that in Halton we have very high standards in respect of safeguarding children and robust responses to Child Protection issues.

6.0 IMPLICATIONS FOR THE COUNCIL'S PRIORITIES

6.1 Children & Young People in Halton

All Children in need are subject to regulated services which will be inspected by Ofsted. It is important that members have a good understanding of the work of the front line teams and are assured that Contact, Referral and Assessment processes are robust and safeguard children.

1.0 PURPOSE OF THE REPORT

- 1.1 To report to PPB on the conduct of and outcomes from Climbie Visits to front line Child in Need Teams.
- 1.2 To review the outcomes from the recommendations reported to PPB on 7 September 09.

2.0 RECOMMENDATION: That

- (1) the PPB note the contents of the report;
- (2) a new and extended list of available Members is agreed by PPB and training offered and a rota of Climbe Visits agreed;
- (3) that following all Climbe Visits the report provided by Members and the responses made by relevant Managers should be reported to PPB and scrutinised twice a year; and
- (4) that the focus of Climbe Visits should give increased scrutiny to the core business of Contact, Referral and Assessment processes and performance data should routinely be discussed and understood.

3.0 SUPPORTING INFORMATION

- 3.1 Training was provided to PPB Members on 1st June this year 09. A further training date need to be arranged to provide both refresher training for those Members who carry out visits and training for members new to this role.
- There are currently five Members identified to carry out Climbie Visits, three in Runcorn and two in Widnes. Visits are carried out quarterly and a report is then sent to the Operational Director for Specialist Services and passed to the Divisional Manager, Children

in Need to respond to any issues raised.

Meeting dates have been set for the year; Widnes visits have taken place on the agreed dates, 21st September 09, 14th December 09 and 31st March 10.

Runcorn visits have again proven more problematic, a visit took place o 17th November 09, February visit did not go ahead and there is one scheduled for 18th May 10.

- 3.3 The purpose of the Climbe Visit is to;
 - Ensure that staffing levels are appropriate
 - Check that workloads of individual workers are appropriate
 - Ensure that referral management processes are sound and secure
 - Check on the performance of the Duty Teams
 - Track the progress of implementation of Integrated Children's System (ICS)
- 3.4 Following on from the recommendation in the last report in relation to increased scrutiny of the core business of Contact, Referral and Assessment processes there has been an increased emphasis on these issues. Many of the issues have been addressed in the 'Children in Need Referral and Assessment Analysis' which has been tabled today these include,
 - Court issues
 - IT issues including Carefirst 6
 - Management vacancies
 - Volume of work.

Additionally issues have been raised about,

- Parking at Midwood house which has been improved with the installation of a barrier but still remains problematic.
- Impact of leave year and suggestion that this should be staggered e.g. by birthdays to take pressure off service delivery especially in March.
- Raised the profile of Conflict Management Training
- Raised the profile of Flu Jabs
- Positive availability of training for front line workers

4.0 POLICY IMPLICATIONS

4.1 Lord Laming's Inquiry into the death of Victoria Climbe recommended that; Chief Executives of local authorities with social services responsibilities must make arrangements for senior managers and councillors to regularly visit intake teams in their children's services department, and to report their findings to the Chief Executive and social services committee. This recommendation remains 'best practice' and still considered as part

of any Ofsted Inspection.

5.0 OTHER IMPLICATIONS

- 5.1 There are two issues which need to be addressed to strengthen the conduct of Climbie Visits.
- 5.2 Firstly there have been some difficulties engaging Members to carry out visits. Visits to the Widnes team are prioritised by the two Members involved and take place at appropriate intervals, however embedding the same process in Runcorn has proved more problematic. All Members involved in Climbie Visits must have an Enhanced CRB Disclosure.
- 5.3 Secondly, training is available for Members carrying out the visits to ensure there is increased scrutiny of Referral and Assessment processes and that performance data is understood, this will ensure that Members have a good understanding of the issues that impact on front line services and ensure that services continue to safeguard and promote the welfare of children in the borough.

6.0 IMPLICATIONS FOR THE COUNCIL'S PRIORITIES

6.1 Children & Young People in Halton

All Children in Need are subject to regulated service provision. From April 2009 there will be annual unannounced inspections of Contact, Referral and Assessment Teams. Climbie Visits afford Members an opportunity to assure themselves that front line teams are providing a standard of service that safeguards children.

1.0 PURPOSE OF THE REPORT

1.1 To brief PPB on the development of Locality working (Teams Around the Family).

2.0 RECOMMENDATION: That the PPB note the contents of this report

3.0 SUPPORTING INFORMATION

- 3.1 The Halton Children's Trust has developed a 'Levels of Need' Framework to help practitioners and managers in the various agencies in Halton to identify the needs of children and young people, and make decisions on how those needs can be met and by which agencies. The Framework operates at four levels, with Level 3 being divided into (a) and (b):
 - **Level 1** children with no additional needs, accessing universal services (including, for example, schools and primary health care)
 - **Level 2** children with additional needs that can be met via CAF and coordinated by a Lead Professional, if a multi-agency response is required
 - **Level 3(a)** children with additional more complex needs that require a multi-agency response coordinated by a Lead Professional either via CAF or a Child in Need Plan
 - **Level 3(b)** children with a high level of needs, where parenting may be compromised and who are at risk of having needs at Level 4 a Child in Need Plan is required
 - **Level 4** children with significant needs and compromised parenting/caring and in need of protection from harm.
- 3.2 The locality working model is composed of the following strands:-

Strand 1: Additional Support around CAF (Common Assessment Framework) Implementation

- Identifying children and young people who should have a CAF
- Identifying children and young people who may have a CAF but who do not need one (i.e. single agency intervention required)
- Challenge and embed robust CAF framework ensuring that CAF is not a barrier to services and does not become a referral process
- Ensure a holistic assessment is undertaken which identifies needs rather than resources
- Undertake some CAF assessments where it is not easily identifiable who should complete that assessment and identify lead professional
- Offer practical support to colleagues undertaking CAF assessments where appropriate – e.g assisting in the identification of resources to support CAF plans
- The development of a Locality Support Forum engaging with all partners who deliver services to children, young people and their families to ensure that services meet identified need

Strand 2: Identifying Local Need and Informing Commissioning

- Develop a good understanding of the needs within the locality
- Have a clear understanding of which agencies are involved with children, young people and their parents / carers to ensure a coordinated approach which meets the needs of all family members (Think Family)
- To share across agencies indicators about children and young people who may be vulnerable to poor outcomes to ensure early identification of need and that services are provided to address these both at an individual and community level.

Basic Principles

- Early identification of need and intervention with children and young
- Holistic support in partnership with a range of service providers including Health, Children's Social Care, Adult Services, voluntary, independent and private sectors (Think Family Model)
- Development of 'CAF Plus' model through support to universal support
- Multi agency commitment to provide a targeted continuum of support, especially to those children who are vulnerable to poor outcomes, to ensure that we deploy our collective resources in the most efficient way possible

- 3.3 There are a number of drivers that point to the need to develop locality working in Halton as a way forward towards an integrated preventative way of working with children and families.
 - a. A report commissioned by Halton Safeguarding Children Board in 2008 – The Halton Level of Needs Framework – The 3b Cases found that there were a cohort of cases that moved in and out of the children in need system quickly and which often lead to re-referrals to Children's Social Care but where a coordinated response is not available once the family is no longer an open case to Children's Social Care.
 - b. A review of the Common Assessment Framework carried out in 2009 found that the joined up multi agency working associated with the role out of the CAF was only evident in some areas of the borough and not in others. Within all the key agencies there were very differential levels of acceptance of CAF as a way of working and overall there were many fewer CAF's than referrals to CSC.
 - **c.** The findings of the localities pilot undertaken within an area of Runcorn which has piloted a supported CAF approach to meeting needs.
 - **d.** The DCSF published it's guidance Early Intervention Securing Good Outcomes for All Children and Young People in March 2010.
 - **e.** "Think Family" guidance which is asking LA's and other key partners to improve the identification and support of adults experiencing problems who are parents or carers; and to coordinate the support that is provided by different agencies to each family, especially those experiencing significant problems.
 - **f.** The findings of Serious Case Reviews in Halton over the last two years have in some instances highlighted the absence of a coordinated response to children and family needs below the level of Children Social Care involvement.
 - g. The increase in demand for specialist services that followed the Baby Peter case points to a need to manage demand for specialist social work services by managing demand much further down the system and having mechanisms designed to meet need at the lowest possible level within the levels of need framework.
- 3.4 We know from the consultative work undertaken as part of the CAF review that there is a general willingness to address needs via the CAF within agencies but that there is a general lack of confidence within the potential pool of lead professionals around their own skills and knowledge. The development of locality teams addresses the very limited support that has been available to lead professionals and as much as anything will be addressing whole children's workforce development issues as well as ensuring that the Think Family element is embedded in work around children and young people.

- 3.5 Children's Centres are closely tied into the localities structure and the development of localities will be looking at enhancing the role of Children's Centres in working with more targeted families. This may lead to some changes in the menu of support currently on offer from Children's Centres. Most if not all of the localities work will be based out of Children's Centres.
- 3.6 A further objective of the development of localities is to better manage the interface between lower level interventions and statutory interventions managed by Children's Social Care. There are often disputes about whether cases can and should be managed via a CAF or need to be dealt with as Children in Need. Indeed one of the reasons given for some agency staff being reluctant to be CAF lead professionals is that they are worried that they will be left holding cases that they don't feel able to manage. One of the principals that it is hoped to establish through locality working is that movement up and down the levels of need for children and families will be seamless. To this end the locality teams will contain social workers seconded from Children in Need who will review cases where the level of need and or risk is increasing and these cases will be moved into the Children in Need system without requiring referral. Equally where cases are coming down from Children in Need the locality teams will put together support for those families so that we avoid the situation where once a case is closed the support ceases and the family ends up being re-referred down the line.
- 3.7 The localities workforce will be drawn from within the current Children's Centre / Children & Young People Area Network (CYPAN) workforce. There is a balance to be struck between these new developments and ensuring that Children's Centres are well managed and meeting their core offer particularly as Children's Centres will be subject to OfSTED inspections. In addition we will be exploring with some of our key partners at the Children's Trust what staffing contribution they are able to make to the locality team in each area.
- 3.8 A number of groups of staff who work at level 2/3 within the levels of need will be based within the localities teams namely the Young Carers workers who have been TUPE'd over to the LA following the insolvency of HIT's and the Family Intervention Project staff who are currently located within Community Safety.

Data Commentary

Actual figure relates to 2008/09 academic year performance across all LA maintained Primary Schools within Halton. Pupil level data is submitted to the LA by each school in the borough; this data is cleaned and validated by LA before being sent to DCSF. This is the final version of this data release.

General Performance Commentary

2009 saw a rise in the % of children at the end of the reception year attaining a score of 6+ across both Personal Social and Emotional Development and Communication, Language and Literacy. This represents a 1.6% increase on 2008 outcomes but was 1.1% below the target set. Key to this increase, specifically around CLL has been the increased focus and range of intervention targeted at the development of language skills through a range of programmes including CLLD (phonic development) and I Can. There have been some improvements over the last 3 years in CLL for children in the 30% SOAs.

Summary of key activities undertaken / planned during the year

The Communication Language and Literacy Development (CLDD) project has been implemented to improve standards of literacy at Foundation Stage. Of the schools participating 91% children were working at phase 2 in EYFS at the end of 2009 compared to 89% nationally. This data is collected by the LA and shared with National Strategies on a termly basis.

To date 86 participants have attended the I Can 'supporting' course and 60 have attended 'enhance up' course. 7 settings have gained accreditation. A further 10 settings are currently going through the accreditation process resulting in a total of 17 settings across private and voluntary and maintained sectors, and rising!

It is expected that the rollout of the SEAD (Social and Emotional Development) programme will impact upon PSED outcomes from Spring 2010. Pilot schools have been identified where historically PSED scores are particularly low.

The Early Years Outcome Duty (EYOD) Steering group is now an established team who have collaborated on a comprehensive action plan to support the achievement of Halton's statutory Early Years Outcomes Duty targets. There is shared accountability for quality assurance across all EYFS settings and the group continues to meet to review impact on a termly basis. Criteria for success to be reviewed and refined in the next action plan.

The LA has identified a range of strategies to further raise attainment including more effective tracking of children's progress across EYFS settings, intake of e-profile data on a termly basis and further analysis of CLLD data from the targeted schools. The intelligence gained from these sources will be used to focus interventions and to inform challenge and support in the EYFS.

The LA has begun to prepare early for its entry into the funded ECAT (every Child a Talker) programme working in partnership with the PCT speech and language expertise to focus on this area. This more joined up approach will hopefully be a contributory factor in the improvements in LCT, and all CLL scales.

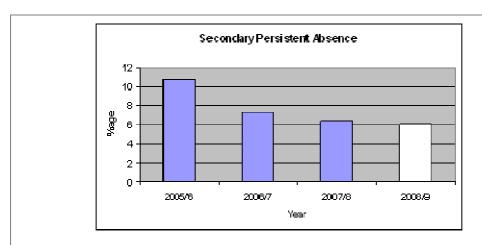

Whilst there has been some success in narrowing the gap from the 2007 / 08 baseline, the gap did not narrow between 2008 and 2009 and as a result the target was not met (-0.75). The gap, between the performance of the lowest achieving 20% of children and the median, widened by 1%.

In 2009, the gap between the mean of the lowest performing 20% of children and the median of all children was widened to 31.4%. The three year period from 2006 to 2009 shows an annual average reduction in the gap of less than one percentage point.

The changes in performance between children in the 30% SOAs and those in the Non 30% SOAs reflect an uneven pattern over a three year period, indicating that the focus on the lowest performing 20% of children is not yet consistent.

Summary of key activities undertaken / planned during the year

A range of activities have developed through the work of the Early Years Outcomes Duty steering group, the detail of which can be found in Halton's EYOD action plan.

Key activities for the coming year include:

- Tighter alignment of all funding streams and resources that can be used for supporting children in EYFS, particularly those children at risk of performing least well.
- Increase use of the CLLD progress data to track children's progress in EYFS in targeted schools and settings.

Figures currently stand at 22.4% compared to 21.4% in 2007/08.

General Performance Commentary

National Child Measurement Programme (NCMP) results for 2008/09 indicate an increase in obesity for Year 6 children. The resultant figures are an increase from 21.4% in 2007/08 to 22.4% in 2008/09. This figure indicates that an increasing number of children in the overweight category have now moved into the obese category. It is particularly important that commissioned services are implemented to meet this need. Fifteen new posts for obesity are now being advertised and teenage weight management services have been procured.

Procured teenage weight management services to be implemented. School weight management action plans to be implemented. Re-configured children's community food workers service to be implemented. In addition placement stability is the focus of much work within the child care and placement provider teams. It is also the focus of work with schools that can be key to helping a child remain in placement. Both the current year and 2011 targets are stretch targets and will be challenging to achieve.

The recruitment, assessment and matching process for foster carers have been significantly enhanced to try to ensure that children are matched to carers who can meet their needs. A similar process takes place within Halton's residential homes where an assessment is completed on any young person referred for a placement to determine the ability of the home to meet their needs and to assess the impact of the young person on an existing cohort. Where placements need to be purchased outside of Halton, information on the qualities of that placement and the ability to meet a particular child's needs is collated and subject to a risk assessment process before the placement is used. Where placements experience some difficulty, support is identified and put into place as soon as is possible. Similarly, if a particular issue is causing some difficulty, agencies are engaged in trying to address it.

The YOT is performing well in terms of reducing the number of first time entrants to the Youth Justice System. This has been influenced by partners from the Police as well as the introduction of the Divert Project.

Summary of key activities undertaken / planned during the year

The YOT through funding via YCAP and the Department of Health has initiated a Diversion scheme for young people. The aim of the scheme is to divert young people, especially those with mental health and learning disabilities away from the Criminal Justice System.

Additional YCAP projects such as Operation Stay Safe and the Friday night reparation project also contribute to the reduction in first time entrants.

The main activity though is the adoption of restorative justice outcomes by Cheshire Constabulary when dealing with young people for the first time or for relatively minor offences.

This data is estimated figure for the full year 2008. This is the latest data we have. Data sources: Termination data from Public Health Intelligence Team; Live Birth data from midwifery discharge database (only one extra conception in comparison to Public Health Intelligence Team data).

General Performance Commentary

The latest and national figures (ONS) show a significant reduction in the number of teenage pregnancies in Halton of 25.9%.

Summary of key activities undertaken / planned during the year

The under 18-conception rate nationally is now 13.3% lower than in 1998. While behind the target to halve the teenage pregnancy rate by 2010, conceptions and births are at their lowest level for over 20 years.

During the life of the strategy, information, advice and support for children and young people, to help them stay safe and healthy and understand the importance of relationships, has improved significantly. Young people also have better access to contraception, when they reach the point at which they begin to have sex. The international evidence-base for the Strategy shows that the two measures for which there is the strongest evidence of impact on teenage pregnancy rates are comprehensive information advice and support-from parents, schools and other professionals-combined with accessible, young people-friendly sexual and reproductive health (SRE).

Sex and Relationship Education (SRE) in schools and post- 16 learning remains patchy. In addition the wider children's workforce is not routinely equipped to talk to young people about their relationships and their sexual health. The aims continue to be to place understanding of sex firmly in the context of loving relationships and to stay healthy when they become sexually active.

Over the past 12 months we have:

- Made local sexual health service information available through a range of locations including doctors, pharmacies, workplaces, nightclubs and other community settings
- Raised awareness of the negative effects alcohol and drugs have on positive sexual health
- Encouraged parents and carers to talk with their children about relationships, sex and sexuality
- Offered sexual health awareness training to workers in the community and health and social care settings
- Increased the number of sexual health clinics and made them young people focussed
- Used the VRMZ outreach bus in hotspot areas on Friday and Saturday nights and during the school holidays, to provide young people with information and advice on positive sexual health
- Further developed teen drop-ins in some schools to include information and advice on relationships and contraception.

Work planned includes:

- Embed and implement young peoples services in the community and increase the number of teen drop-ins in schools
- Fully utilise MyPlace for integrated services developments
- Continue to ensure the VRMZ outreach bus provision is accessible to young people across Halton providing universal and targeted interventions
- Further develop holistic college and work based sexual health services for young people that are more responsive and flexible and take into account the differing needs of young people.

General Performance Commentary

The results indicate that more young people answered that they are misusing substances than previous surveys, and Halton's performance is higher than the national and regional averages.

Summary of key activities undertaken / planned during the year

Halton has submitted its Treatment Plan for 2010/11 and received the following feedback: The NTA North West strongly feel your plan is truly fit for purpose to guide the specialist substance misuse treatment system, within the wider approach of the Children and Young Peoples arrangements, for the year ahead, with Halton remaining one of our regional best examples of a successful and inclusive system.

Under 18s substance misuse services are now dominated by alcohol, cannabis, cocaine and ecstasy (ACCErs) in most of the UK. The 2008 Drug Strategy encouraged a more recovery focused treatment systems, aimed at getting drug and alcohol users back into education, employment and training. The profile of drug and alcohol users in Halton is consistent with the rest of the UK, with alcohol and cannabis being the drugs used most by young people. The Tell us survey 2009 told us percentage of young people reporting drug use in Halton is 1% higher then our statistical neighbours. Further work is required focussed through the Children and Young People's Plan to reduce the number of Halton's Young People involved in substance misuse.

Data Commentary

The above data on the <u>total number</u> of children in families in receipt of out of work benefits by the local authority was made available on the DWP website. This presents the data in a different format to the data previously released and used to calculate the baselines. Following the earlier loss of child benefit data records by HMRC in 2007 restrictions have been in place on both the provision and use of child benefit data. DWP have agreement to publish the numbers released yesterday but not to use the Child Benefit data to calculate the existing proxy targets.

Early investigation of the population estimates suggests that for some Local Authorities it may lead to a slightly different proportion of children in families in receipt of out of work benefits. However the trends in the data will be robust and consistent and will allow us to track progress effectively. Therefore the change should not adversely impact the targets themselves.

The target for this measure, following discussion with Government Office North West is to narrow the gap between Halton and the North West average form a baseline of 5.6% in 2007/08 to 4.6% by April 2011.

General Performance Commentary

Performance provided in relation to this indicator indicates that there was a 5.1% decrease in the percentage of families in receipt of out of work benefits over the 5 years of the data collection. Halton is on target to meet the new target agreed with GONW as latest performance indicates a gap of 4.8%.

Summary of key activities undertaken / planned during the year

As an area of focus for the Children and Young People's Plan a sub-group has been established to focus on some tasks to tackle child poverty, whilst recognising this is an issue for all of the LSP due to the magnitude of the issue.

The Local Authority Child Poverty meeting has taken place with a view to producing the Child Poverty Strategy for March 2011.

Data Commentary

The national NEET performance target is the average percentage NEET in November, December and January each year. This figure there for represents the latest actual data i.e. for November 2009 – Dec 2010

General Performance Commentary

The data shows a large reduction in NEET for those months in 2009/10 compared with 2008/9 however there is still some way to go to reach the target. In real terms this represents a reduction in NEET from 534 in 2008/9 to 393 in 2009/10.

The year-on-year reduction in numbers of NEET is 21%, in comparison with the England average reduction of 7.5%. The percentage of 16.18 year olds NEET has reduced to 10.3% in 2009/10 from 13.2%.

Summary of key activities undertaken / planned during the year

Action is taking place in accordance with the NEET Strategy and Action plan. Actions include the implementation of the Working Neighbourhood Fund apprenticeships programme. This has been in operation from April 2009 and has been further extended for 2010/11. The working neighbourhood apprenticeship programme was implemented in April 2009 and is being managed by Halton People into jobs. All 100 places have been obtained and further funding to expand the programme through 2010/11 is being sought.

An 'at risk' matrix for early identification of young people at risk of becoming NEET is being developed to allow for targeted intervention.

Access to provision is more flexible particularly at Riverside College who have extended their main enrolment to the end of October and introduced January and March enrolments also.

A September Guarantee group meets frequently to carry out forensic monitoring of the NEET cohort to ensure that new joiners are picked up promptly and targeted support is taking place with longer term NEET

The KS4 Gateway is working with learners who are pre sixteen and have been identified as being at risk of becoming NEET to engage them on an

appropriate pathway. Gateway plus is providing a service around young people who have not or who have dropped out of traditional learning pathway.

Data Commentary

The above figures are based on data supplied by Cheshire Police on a calendar year basis. The figure '0' indicates that the latest 2009 3-year rolling average figure is the same as the previous 3-year rolling average.

General Performance Commentary

Excellent progress has been made in reducing child deaths/serious casualties (CKSI) on Halton's roads. From a 1994-1998 average figure of 33 per annum, the 2007-2009 three year average is 9 (approx figures).

The progress that has been made in Halton exceeds that made nationally in terms of CKSI, but the average rate of child death/serious injury for those under 16 years old remains higher than the current national norm, even though there has been a large effort in this area locally since the 1990's. There is evidence that the trend for the average annual CKSI total is tending to 'flatline' despite a range of targeted initiatives, and consistently reducing the numbers appreciably in the future looks to be a stiff challenge. With no one 'big fix' on the horizon, established methods for reducing child casualties will have to be refined and efforts redoubled.

Summary of key activities undertaken / planned during the year

The large reductions in casualty and accident numbers in Halton have been achieved through the rigorous application of conventional traffic engineering methods backed by the latest available national guidance and supported by road safety education, training and publicity initiatives (RSETP).

The role the Council's road safety unit plays in educating and training children and adults and publicising road safety is invaluable and makes a significant contribution towards the prevention of accidents to children within the Borough, both while travelling to school and at other times. Whilst RSETP can be specifically targeted towards children's needs, the lack of any

correlation between deprivation and casualties requires that local safety schemes will continue to be implemented on the basis of casualty concentrations and the viability of schemes to address specific issues.

The national Road Safety Strategy "Tomorrow's Roads – Safer for Everyone" set out a framework for delivering road safety to help achieve its established long-term casualty reduction targets, which are to be reached by 2010. Halton Borough Council's RSETP programme has continued to develop in line with the strategy and has contributed to the overall downward trend in casualties alongside engineering and enforcement strategies. The working relationship the Unit has with schools is excellent and the partnership will continue and develop its role in educating children in matters of road safety. Road safety initiatives provide opportunities to raise the general awareness of safety issues and to deliver advice and training to a wide audience. The influencing of behaviour and attitudes of all highway users is now seen as being central to gaining further lasting reductions in road casualties in Halton.

Data Commentary

Data for the TellUs4 Survey was weighted differently than previous surveys. The DCSF have reweighted the results from the TellUs3 in line with new methodology. Targets set against previous weightings will require reviewing in light of the new data.

General Performance Commentary

There has been a 9.7% increase in children and young people satisfaction with parks and play areas on 2008/09 TellUs Survey. Halton's performance is above the regional average, but below the national average.

Summary of key activities undertaken / planned during the year

Halton now has another two playgrounds which were completed in the Easter holidays with a total investment of over £400,000. Spike Island playground in Widnes is an all-new facility built near the approach to Catalyst science and discovery centre which, as well as providing adventurous play, significantly

improves this part of the park. Facilities include a range of equipment suitable for everyone from toddlers to teenagers, all of which has been designed with the theme of the chemical industry to emphasise the link with the Catalyst centre.

Meanwhile in Runcorn the community play area at Wellington Street has had a major boost following public consultation. This much-loved space has now had a makeover to include many new features that are accessible to all. These latest play area improvements are further examples of the Council's commitment to improve facilities for young people.

The play areas were designed by Halton Borough Council's Open Space Services Division, in close consultation with local residents. They were funded by the Council, the Local Area Forum, the Government's Playbuilder initiative, Play England and Big Lottery Fund.

This figure is from the first data release from RM Solutions and represents the data version that Schools are currently checking as part of the AAT checking exercise.

General Performance Commentary

Performance for the baseline was 49% for all Halton and 26% for those in 10% most deprived LSOA. Performance at 2009/10 was 44.4% for all Halton and 30.8% in the 10% most deprived LSOA. Therefore the gap has increased.

Summary of key activities undertaken / planned during the year

Key Activities include the following:

- A full review of results has been undertaken by the Local Authority and schools
- Schools have considered whether the exam board that is being used is appropriate for all students
- Exam boards have been invited into schools to provide feedback and professional opportunities for teachers to improve the readiness for students for the exams
- Analysis has considered the performance of sub groups of students by ability, gender, Free School Meals, Children in Care, etc to examine if there are particular issues that the schools needs to respond to
- Consultants have been aligned with schools most at need and are undertaking a number of activities to support schools in raising there performance
- Schools are actively looking to share good practice more and a Teaching and Learning and Management hubs have been created
- Additional funding continues to be available for our National Challenge schools to continue to make progress. Both showed slight improvements from the previous year's results
- School Improvement Partners will continue to challenge and support schools in achieving the aspirational target for this academic year

1.0 INTRODUCTION

This quarterly monitoring report covers the Specialist Services Department fourth quarter period up to 31st march 2010. It describes key developments and progress against all objectives and performance indicators for the service.

Given that there are a considerable number of year-end transactions still to take place a Financial Statement for the period has not been included within this report in order to avoid providing information that would be subject to further change and amendment. The final 2009 / 10 financial statements for the Department will be prepared and made available via the Council's Intranet once the Council's year-end accounts have been finalised. A notice will be provided within the Members' Weekly Bulletin as soon as they are available.

The way in which symbols have been used to reflect progress to date is explained within Appendix 7.

2.0 KEY DEVELOPMENTS

2.1 Aiming High for Disabled Children (AHDC)

The programme has delivered short breaks for 333 disabled children and young people against a target of 250 for this year. New initiatives have included the development of a Saturday club in two children centres providing fortnightly sessions for 8 young disabled children. This is being extended to accept more children in the next few weeks.

The second Powerful Voices conference was held on 11th March with over 70 parent carers and professionals attending to hear about the AHDC developments and to share their views on the services delivered, the quality and value of the information they receive and told us what they would like to see developed in future. This information is being used to inform the communication strategy.

On 5th March Halton AHDC Programme has been assessed as meeting the Full Service Offer requirement for short breaks delivery, which needed to be achieved by all Pathfinders by end of March 2010.

2.2 Staffing

To address the current level of frontline manager vacancies, proposals to address the competitiveness of current salaries have been agreed in principle by the Council, and recently the outcome of the managers' job evaluation appeal was successful, resulting in the grade being increased. Following a national and local recruitment advert for managers and a successful open evening, this appears to have produced more applicants than previous advertising.

2.3 Working Together 2010

In response to the Baby Peter tragedy, the government has published revised guidance for agencies working together to safeguard children and young people. Halton Safeguarding Children Board is currently reviewing the document to determine what changes need to be made to local policy and procedures.

3.0 EMERGING ISSUES

3.1 Unannounced Inspection

Halton is still awaiting our Unannounced Inspection for Contact, Referral and Assessment and it will now take place in the next quarter, as the deadline for all inspections being completed is June 2010.

3.2 New Children and Families Department

The Council's new service structure came into being on 1st April, including the new children's department, which brings together services for children across the levels of need, from Universal to Specialist. A new locality service, focussing on targeted early intervention, is being created as part if the new structure, and that this ensure over time, that the needs of the most vulnerable children and families are met much earlier, thus improving outcomes and reducing the need for crisis interventions.

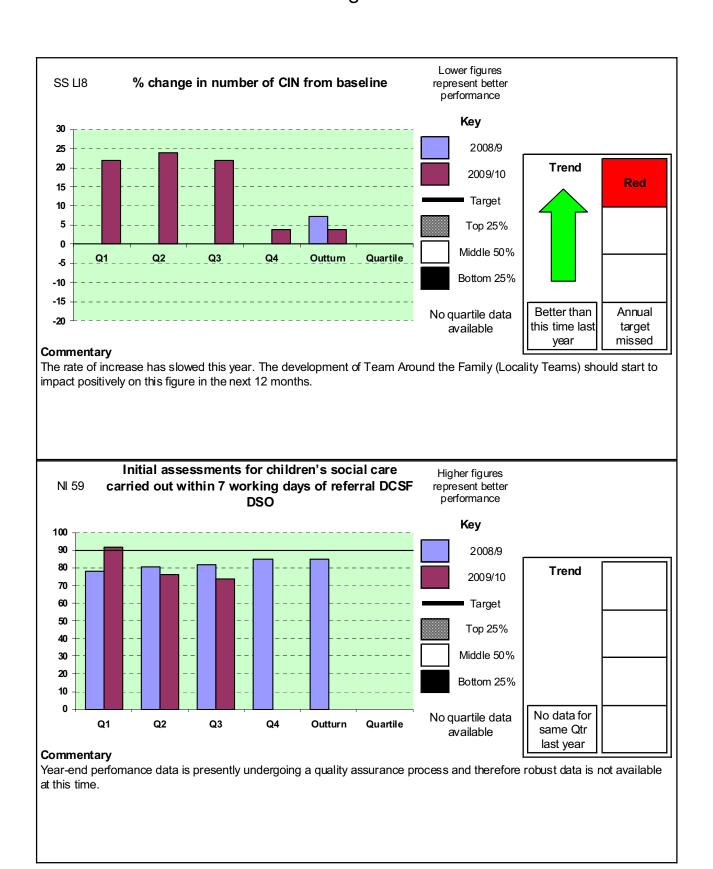

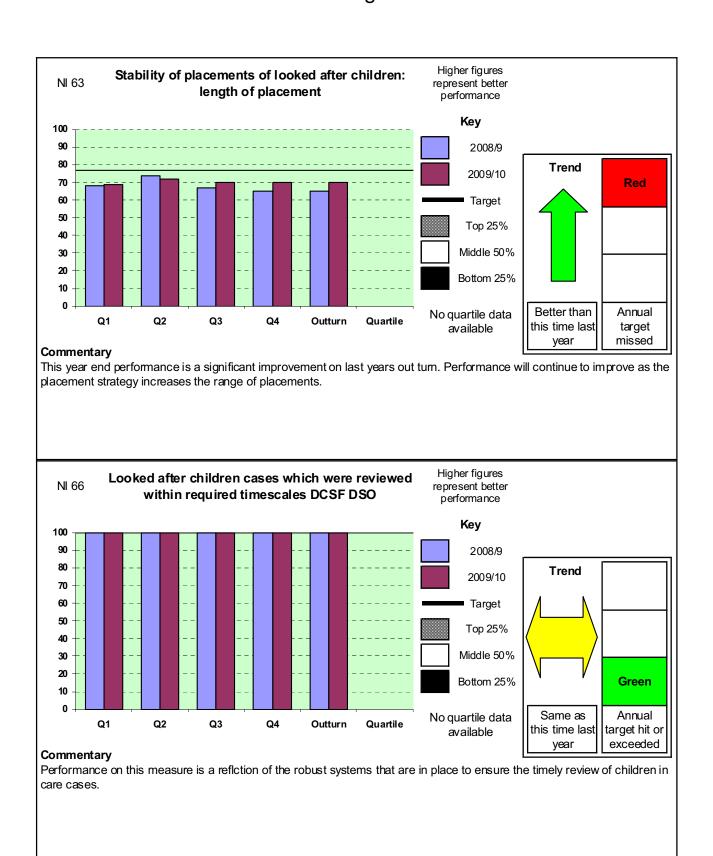

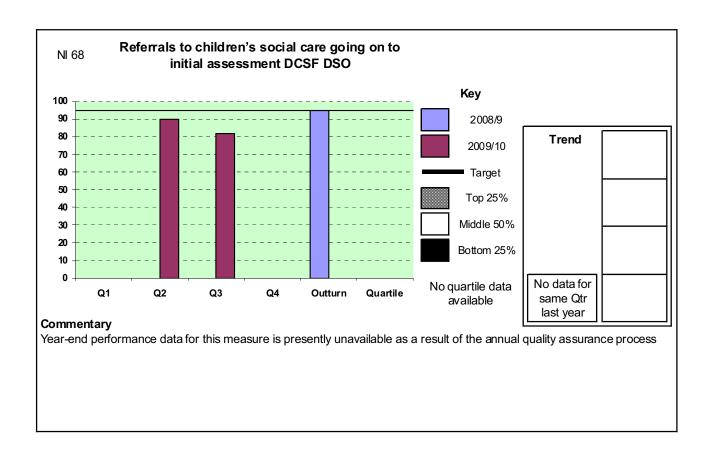

SERVICE: Universal & Learning Services

PERIOD: Quarter 4 to year-end 31st March 2010

1.0 INTRODUCTION

This quarterly monitoring report covers the Universal & Learning Services Department fourth quarter period up to year-end 31st March 2010. It describes key developments and progress against all objectives and performance indicators for the service.

Given that there are a considerable number of year-end transactions still to take place a Financial Statement for the period has not been included within this report in order to avoid providing information that would be subject to further change and amendment. The final 2009 / 10 financial statements for the Department will be prepared and made available via the Council's Intranet once the Council's year-end accounts have been finalised. A notice will be provided within the Members' Weekly Bulletin as soon as they are available.

The way in which traffic lights symbols have been used to reflect progress to date is explained within Appendix 7.

2.0 KEY DEVELOPMENTS

2.1 The Lamb Enquiry

The Lamb Enquiry was requested to look at how parental confidence in the special educational needs system could be improved. Because of emerging issues during the period of the Inquiry, it also covered SEN and disability information; the quality and clarity of statements; inspection and accountability; and what impact the changes in the Tribunal system were having on parental confidence.

This has required the local authority to consider the legal implications of the Lamb Enquiry recommendations for example the impact on provision and the impact of greater child and parental voice.

2.2 Drop in Sessions for School Staff

Weekly drop in sessions for school staff have been offered by Specialist Teachers in conjunction with Speech and Language Therapy Service offering advice and support around Autism, SPAL Enhanced Provision, Transition, Visual Impairment, Hearing Impairment, Medical Needs, Cognition and Learning, including specific Learning Difficulties. Proposals for drop in sessions for parents around specialist areas need

have been developed, with the intention of having locality based venues for delivery.

2.3 Early Years Foundation Stage Profile

Training has been provided in EYFS data for School Improvement Partners (SIPs) to help them to identify issues for discussion with head teachers.

2.4 Primary - writing

A key focus continues to be on development of writing, including more able writers, through training and school support. Need to further develop attendance at Continuous Professional Development Literacy but numbers are increasing.

3.0 EMERGING ISSUES

3.1 14-19 provision

The Learning and Skills Council will cease to exist on 1st April 2010 and responsibility for the planning and commissioning of post 16 provision will be transferred to the Young People's Learning Agency and Local authorities. B There could be significant changes to the post 16 landscape through Presumption and Academy development that will affect coherent planning.

3.2 The White Paper

There are a range of implications arising from the recent Parliamentary 'wash up' and the impact upon the White Paper.

Clauses on a number of key provisions were removed, including; the Pupil and Parent guarantee, Home School Agreements, reform of the primary curriculum, introduction of compulsory Personal Social Health and Economic (PSHE) education – including the provision that all children receive at least one year of sex and relationship education, the licence to practise for teachers, registration and monitoring of home education, the extended remit for School Improvement Partners, school report cards, strengthened powers for local authorities and the Secretary of State to intervene where schools are causing concern, powers for the Secretary of State to intervene in failing Youth Offending Teams, parental satisfaction surveys.

The provisions that remain in the Bill include;

- requirements for school inspections to take into account the needs of pupils with special educational needs (SEN) and disabilities and provisions for an additional right of appeal for parents of children with special educational needs statements
- a requirement for local authorities to provide full-time education for children and young people who, for various reasons, are in alternative provision

- greater powers for school governing bodies on how they use their budgets, and the power to set up new schools and academies
- new provisions on information sharing and the review of Local Safeguarding Children Boards' performance
- new arrangements to allow greater media reporting of proceedings in Family Courts

Approach to work within the department will be affected by these changes and development work will be linked to the requirements of the White Paper.

3.3 EYFS/Primary

The department will need to continue training and support in use of the EYFS data. Head teachers to be briefed in June around emerging issues. Focus to continue on addressing issues around writing and more able writers.

3.4 Inclusion

Resource bases capacity required to be fit for purpose by 2011 and allocation of funding to support this development to be agreed by September 2010 in readiness for 2011 delivery.

Tribunals and related costs to local authorities from tribunal judgements in relation to placement and provision for children and young people with Autism will require some focus over the coming months.

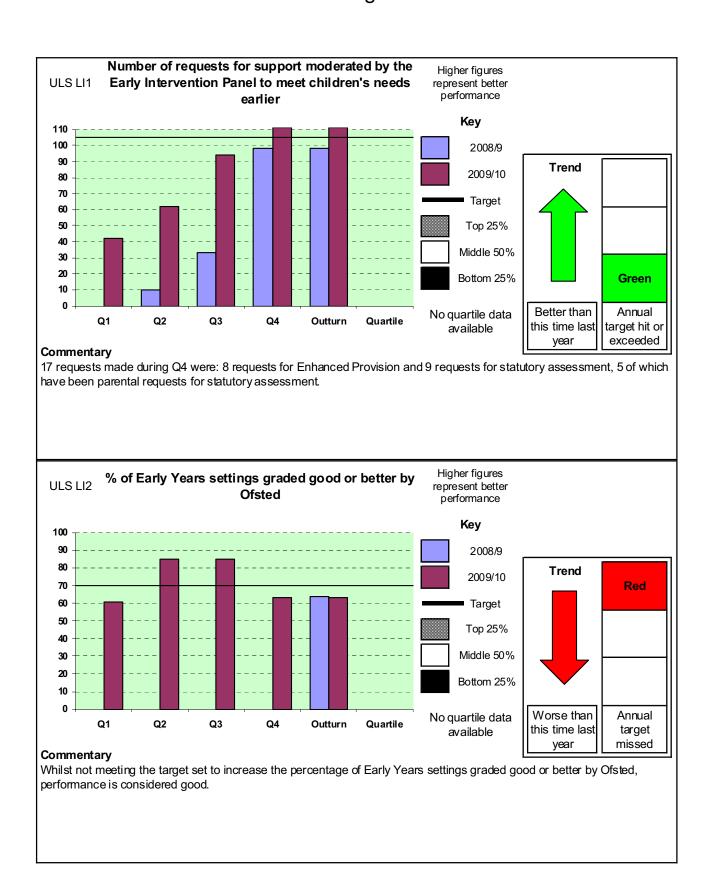

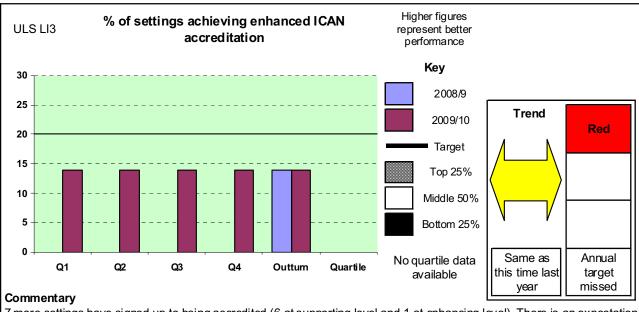

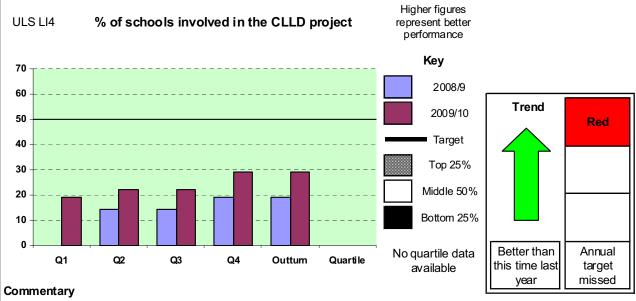

PERIOD: Quarter 4 to Year-end 31st March 2010

1.0 INTRODUCTION

This quarterly monitoring report covers the Preventative Services Department fourth quarter period up to 31st March 2010. It describes key developments and progress against all objectives and performance indicators for the service.

Given that there are a considerable number of year-end transactions still to take place a Financial Statement for the period has not been included within this report in order to avoid providing information that would be subject to further change and amendment. The final 2009 / 10 financial statements for the Department will be prepared and made available via the Council's Intranet once the Council's year-end accounts have been finalised. A notice will be provided within the Members' Weekly Bulletin as soon as they are available.

The way in which symbols have been used to reflect progress to date is explained within Appendix 7.

2.0 KEY DEVELOPMENTS

2.1 Teenage Pregnancy

The latest local and national figures (ONS) show a significant reduction in the number of teenage pregnancies in Halton of 25.9%. We have worked closely with the National Support Team from Central Government to implement the most effective evidence of good practice to tackle this issue and we have recently extended provision to a full range and choice of sexual health information, advice and services.

2.2 Substance Misuse

Halton has submitted its Treatment Plan for 2010/11 and received the following feedback: The NTA North West strongly feel your plan is truly fit for purpose to guide the specialist substance misuse treatment system, within the wider approach of the Children and Young Peoples arrangements, for the year ahead, with Halton remaining one of our regional best examples of a successful and inclusive system.

2.3 Children's Centres

Windmill Hill Children's Centre was given Full Core Offer approval,

following a visit from Together for Children in January. This now means that 100% of Halton's Children's Centres are meeting the requirements of Full Core Offer which includes early education, childcare, play and learning, support for childminders, health and Jobcentre plus services. Outreach and family support and support for disabled children.

DCSF has approved Halton's reduction in main Children's Centres from 12 to 8 to ensure future sustainability of services; the main sites are Ditton, Brookvale, Halton Lodge, Halton Brook, Kingsway, Warrington Road, Upton and Windmill Hill.

3.0 EMERGING ISSUES

3.1 Teenage Pregnancy

The under 18-conception rate nationally is now 13.3% lower than in 1998. While behind the target to halve the teenage pregnancy rate by 2010, conceptions and births are at their lowest level for over 20 years. During the life of the strategy, information, advice and support for children and young people, to help them stay safe and healthy and understand the importance of relationships, has improved significantly. Young people also have better access to contraception, when they reach the point at which they begin to have sex. The international evidence – base for the Strategy shows that the two measures for which there is the strongest evidence of impact on teenage pregnancy rates are comprehensive information advice and support-from parents, schools and other professionals-combined with accessible, young people – friendly sexual and reproductive health (SRE)

Sex and Relationship Education (SRE) in schools and post- 16 learning remains patchy. And the wider children's workforce is not routinely equipped to talk to young people about their relationships and their sexual health. The aims continue to be to place understanding of sex firmly in the context of loving relationships and to stay healthy when they become sexually active.

3.2 Substance Misuse

Under 18s substance misuse services are now dominated by alcohol, cannabis, cocaine and ecstasy (ACCErs) in most of the UK. The 2008 Drug Strategy encouraged a more recovery focused treatment systems, aimed at getting drug and alcohol users back into education, employment and training. The profile of drug and alcohol users in Halton is consistent with the rest of the UK, with alcohol and cannabis being the drugs used most by young people. The Tell us survey 2009 told us percentage of young people reporting drug use in Halton is 1% higher then our statistical neighbours. Further work is required focussed through the Children and Young People's Plan to reduce the number of Halton's Young People involved in substance misuse.

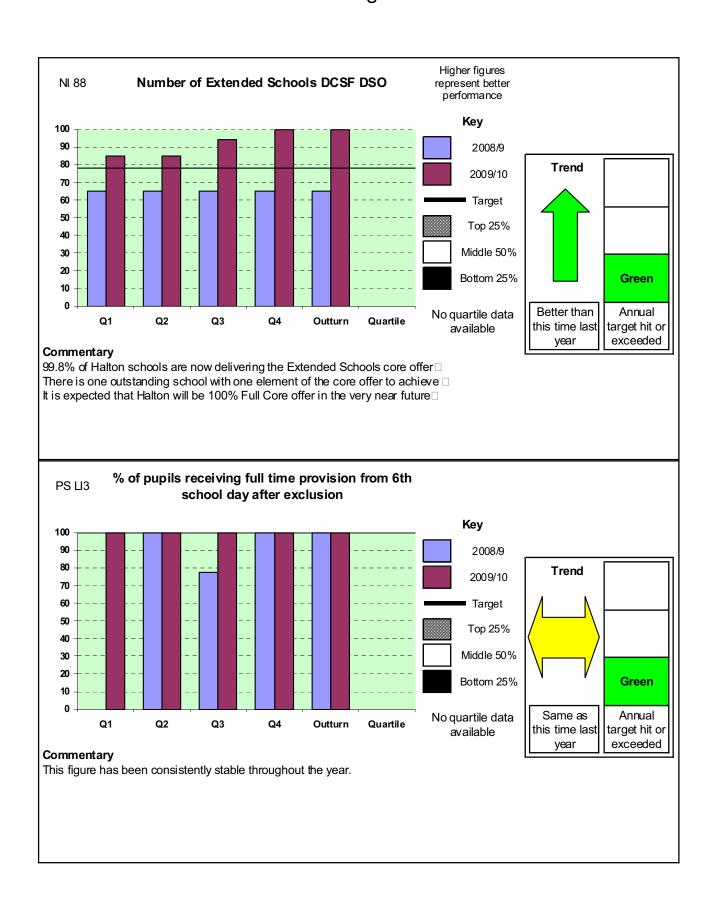

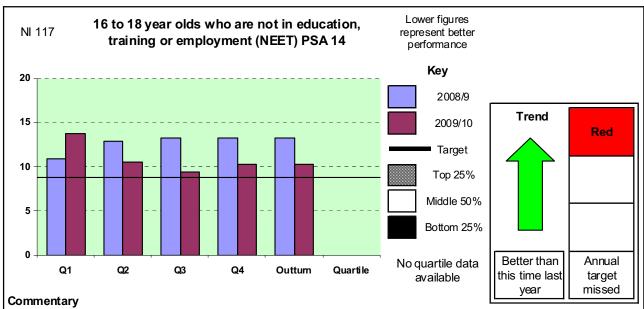

PERIOD: Quarter 4 to Year-end 31st March 2010

1.0 INTRODUCTION

This quarterly monitoring report covers the Business Support & Commissioning Department fourth quarter period up to year-end 31st March 2010. It describes key developments and progress against all objectives and performance indicators for the service.

Given that there are a considerable number of year-end transactions still to take place a Financial Statement for the period has not been included within this report in order to avoid providing information that would be subject to further change and amendment. The final 2009 / 10 financial statements for the Department will be prepared and made available via the Council's Intranet once the Council's year-end accounts have been finalised. A notice will be provided within the Members' Weekly Bulletin as soon as they are available.

The way in which symbols have been used to reflect progress to date is explained within Appendix 6.

2.0 KEY DEVELOPMENTS

2.1 Children's Trust and HSCB Joint Frontline Event

On 11th February 2010 the Children's Trust and Halton Safeguarding Children Board held a joint event for frontline staff working within and alongside children's services across the borough. Two sessions were held to allow the maximum number of staff to attend. The aim of the event was to enable front line staff to engage directly with both Children's Trust and HSCB Members. Staff were updated on both current and future developments within Children's Services, and had opportunity to give their views about the issues they face in delivering services to children and families in Halton. The two sessions covered the Children's Trust priorities and structure, the relationship between the Children's Trust and the HSCB, joint commissioning and Common Assessment Framework review. Feedback from the event was extremely positive.

2.2 Workforce

As a result of Halton Children's Trust impressive response rate in relation to the One Children's Workforce Tool (OCWT) in the Summer of 2009 and the Integrated Working element in December 2009, the authority was nominated by the regional Children's Workforce Development Council (CWDC) to take part as a case study in a national evaluation of the tool.

Halton Children's Trust was 1 of only 6 nationally selected case study sites who had been asked to help assess the use, relevance and impact of the OCWT. In early March, 2 representatives of the University of the West of England undertook a series of 1 to 1's with key members of the Children's Trust, as well as observing a focus group in order to ascertain ideas, thoughts and concerns about the tool. The University will produce a written report covering all of the 6 selected case studies. This information will be available for use to national professional trainers and management developers in this respect Halton Children's Trust is influencing the national direction of a concept which is ultimately designed to create a world class children's workforce.

3.0 EMERGING ISSUES

3.1 School Organisation

The outcome of the statutory consultation on expanding The Heath A Specialist Technology College from 1050 to 1350 will be considered by Executive Board. If approved the expansion will take place once The Heath has been rebuilt. The Executive Board will also consider the proposals to re-organise the primary special unit provision. proposed provision is designed to provide flexible provision within mainstream schools that allows pupils to spend as much time as possible learning alongside their peers, depending on their individual The proposals provide a continuum of provision from needs. mainstream through to special school provision for pupils with these The new provision will include 14 places for pupils with Behaviour, emotional and social difficulties, 28 places for pupils with a diagnosis of Autistic Spectrum Disorder, 34 places for pupils with speech and language and communication difficulties, 10 places for pupils with severe learning difficulties and 6 places for pupils with hearing impairment and specific learning difficulties.

3.2 Childcare Sufficiency Assessment

The Local Authority is statutorily required under the Childcare Act 2006 to produce a Childcare Sufficiency Assessment, agree an action plan, and undertake market management of childcare providers. The Sufficiency Assessment will ensure that there are sufficient places within the childcare sector to enable parents to work, or undertake education or training leading to work. The 2010/11 assessment commenced in March 2010 and involves a wide range of stakeholders including the Family Information Service, Job Centre Plus, Health, Childcare Providers, Parents, Employers, Management Information and Research Services, Youth, Play and Extended Services, Services for Disabled Children, Businesses and Economy. A wide range of qualitative and quantitative data will be collected and will help to shape the future childcare provision within the borough. A final report will be published by 1st April 2011.

3.3 Children and Young People Plan Update

A review of Halton's Children and Young People's Plan is underway and will be completed by the end of June 2010. The review is being carried out in line with national guidance and will focus on providing an update on progress on delivering the Plan. This will include a performance update around the priorities using relevant data, identify the barriers that are impeding progress, outline the actions that will be taken in partnership to achieve the agreed priorities and by when and also include the views of children and young people. Although in terms of performance many of the indicators will remain the same until a new CYPP is in place in April 2011, some of the indicators currently in the Plan may be refined where it is possible, appropriate and beneficial in the interim.

3.4 Early Years Capital Grant

An element of the Early Years Capital Grant has been allocated to purchase a computer package for every childcare provider in Halton, provided they are registered on the Ofsted Early Years Register. This project will enable early years settings to complete the Ofsted Self Evaluation Form on-line. It will also ensure that settings have access to other advice and guidance such as the SEN Handbook (The Source) and Halton's Planning and Implementing Early Years Foundation Stage documents.

3.5 BSF

The second round of Competitive Dialogue commenced on 23rd February 2010. A range of meetings have been held on Partnering, Design, Legal, Finance and ICT. The Dialogue is due to finish in June 2010. The indicative key timetable for the programme is as follows:

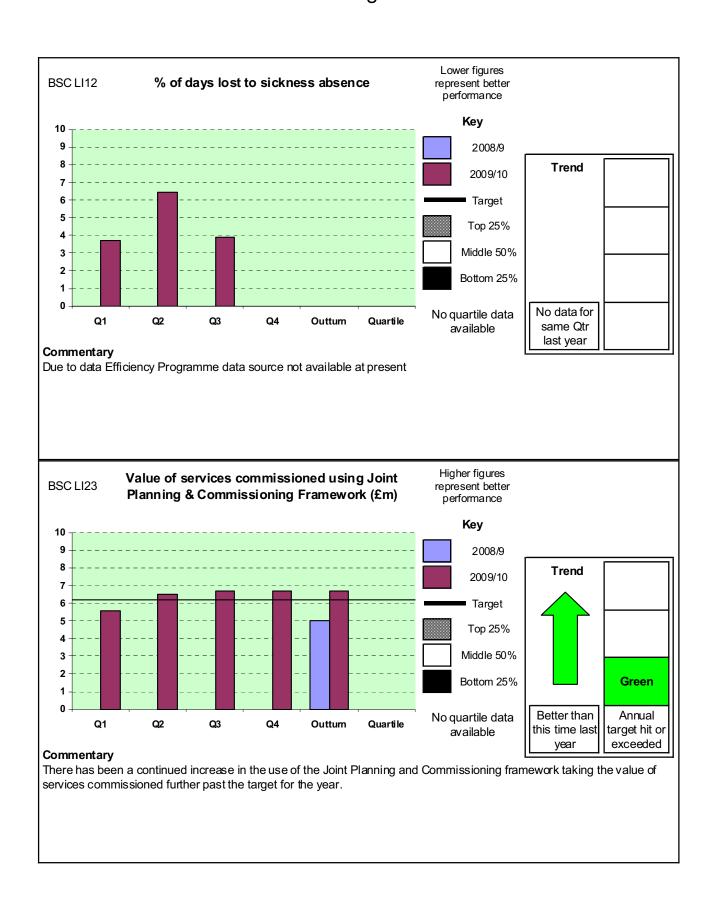

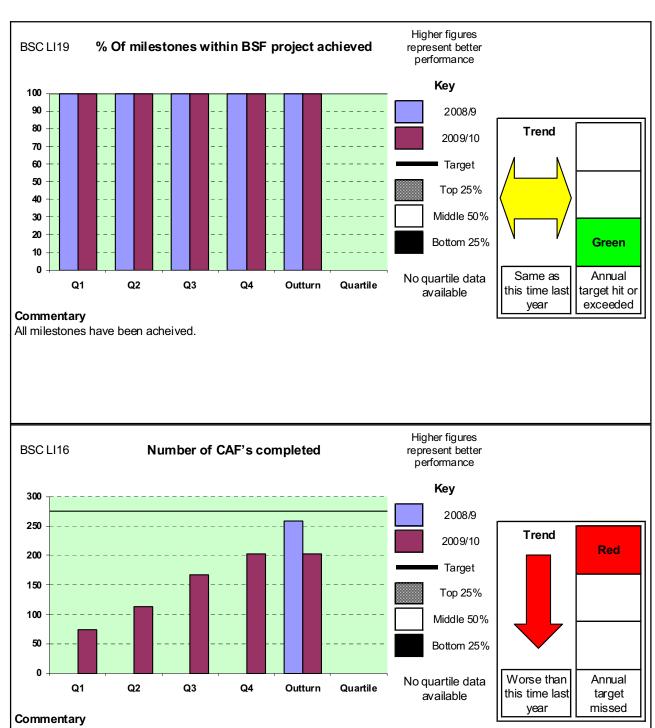
