Request £60,707.83. AP outlined scheme, discussed effect of request for outside funding relating to Widnes Memorial. BW – is funding available from British Legion? AP not as far as we are aware. MW Outlined position re Hale memorial. BW could we wait until outcome of outside bid is known. BW summarises, approve 3 Runcorn and 1 Hale and await outcome for outside bid for Widnes. AP offers to provide update. We are allocating £48958 MW – suggests liaison with Hale PC Clerk.

 Sewer Gas Destructor Lamp Refurbishment and Interpretation – Submitter Cllr Pauline Sinnott

Request £7636.67. Discussed, all members are supportive, agreed to allocate £7636.67

 Environmental Improvement Contingency Fund – Submitter: Jimmy Unsworth

Request £15,000.00 on an ongoing basis – AP outlines the intent of the scheme. Will provide flexibility to deal with small works up to £1000 per project. BW enquires if Community Payback still used? AP yes. MW discusses the intent of the scheme. AP will update members of how funds are used and maintain element of control over uses. Agreed to support.

 Halton Lodge Play Area Improvements – Submitter: Christine Walker Halton Housing Trust

Request £12500.00. AP outlines, park has been closed, Ward Cllrs keen to keep park open, scheme is jointly supported. BW – do we at times with play

areas throw "good money after bad" as they are often vandalised? Agreed to support

Runcorn Hill Bowling Green – Submitter: Martin McCoy

Request £52507.10. AP outlines. MW – have we approached external funding? BW – is green needed if it is currently "redundant"? Agreed to defer. AP to arrange Paul Wright to attend next meeting to provide information.

• Barrows Green Widnes – Submitter: Martin McCoy

Request £156583.17. MW – suggests defer until next meeting to allow time to discuss with Cllr Polhill and for Paul Wright to be in attendance. Deferred

• Runcorn Hill Footbridge – Submitter: Martin McCoy

Request £21266.00. Discussed where this would normally be funded from. Is there capital budget. BW – discusses joint funding, can contribution be sought? Deferred to meeting with Paul Wright in attendance. Deferred

Sanders Hey Play Area – Submitter: Chris Featherstone on behalf of Councillor Martha Lloyd-Jones

Request £8000 over 3 yrs (£2667 pa). RH outlines scheme. BW speaks re scheme and support from Area Forums. Is maintenance cost within remit of EfW scheme? AP advises members on scope of EfW scheme. RH – this is a community improvement and may have wider benefits. BW discusses similar in Upton Rocks. MW suggests request for play equipment might be more acceptable. AP suggests he asks them to re-draw the scheme and request.

Town Park, Southern Path & Street Furniture Improvements. Submitter: Martin McCoy

Request £209,000 BW asks how much allocated to Town Park so far? (£130,000 for Ski/Railway, £350,000 Town Park Team). AP outlines aspirations. MW suggests defer to meeting with Paul Wright present to discuss "Masterplan". Deferred

Widnes SUD North to South Route. Submitter: Highways and Open Spaces

Request £205,652.54. AP Outlines – could be split over period and scheme brings in other funding. MW – clarifies that this may not happen if other funding not secured. Agreed to support on terms of split over period of years.

• Runcorn Station Quarter, Submitter: Sara Munikwa

Request £50,000. MW questions ongoing nature. BW details scheme and asks why EfW are being asked to assist? AP outlines – will not be available to spend without further detail, this is essentially banking money for future

requests, i.e to build a contingency for the Quarter. BW – for a scheme potentially costing millions what will the EfW contribution pay for? BW suggest not agreeing but "ringfencing" funds within the scheme but not specifically allocated. Agreed to proceed on this basis.

Discussed funding from Joint Authority. Discussed potential uplift in income from increased processing at site.
