(noise sensitive locations being any occupied premises outside the site used as a dwelling (including gardens) place of worship, educational establishment, hospital or similar institution or any other property likely to be adversely affected by an increase in noise level)	
- the DPS/Manager shall ensure that patrons leave the external eating area no later than 23.20 hours Monday – Saturday and 22.30 Sunday.	
In view of the above amendments the Environmental Health Department withdrew their representation.
