4.1 **RESPONSIBLE AUTHORITIES**

- The following responsible authorities have made relevant representations Environmental Health
- The relevant representations relate to Environmental Health
 - All doors and windows must be kept closed when amplified music or voices are being played.
 - Any live music played at the premises shall be played through a noise limiting device. The activation level of this device must

be set and sealed by an officer of the Local Authority's Environmental Health division

- No speakers shall be used outside the building this will include any beer gardens or outside drinking area or car park.
- The activities specified in Sections E (Live Music) the application shall cease at 23:00 hrs on every occasion.
- The activities specified in F of the application shall cease at 23:30 hrs on every occasion.
- Drinking outside shall cease at 22:00 hrs and the patrons shall return inside the pub.
- Sale of alcohol shall be permitted until 00:30 hrs and the premises shall close at 01:00 hrs on Christmas Eve and Boxing Day
- On the Friday and Saturday of a bank holiday weekend the hours of operation and licensing shall correspond with those agreed at all other times (except New Years Day, Boxing Day and Christmas Eve when the hours shall be permitted to the time specified in the application in sections M & O)

4.2 INTERESTED PARTIES

- The relevant representations relate to
 - Proposed extension of licensing hours will cause unacceptable noise and behaviour.
 - Currently disturbed by patrons leaving the premises who are shouting arguing swearing fighting and banging car doors which would be unbearable if present hours are increased
 - Unable to sell property due to premises
