#### **Environmental Health**

Environmental Health would not object to the application in principle subject to the following conditions

o The use of any outside area shall cease at 23:00 hours.

0

- No external speakers shall be used outside the building; this will include any beer gardens or outside drinking area or car park.
- I would consider that the hours the premises should be open to the public should be: Sunday to Thursday 10:00 &00:00 hours; and Friday and Saturday 08:00 & 01:00 hours.
- All regulated activity will cease a minimum of 30minutes prior to the closure of the premises.
- Noise from any regulated entertainment (categories E,F,H & J) shall be inaudible at the nearest noise sensitive property at any time.
- An extension to the above hours shall be permitted on the Sunday of any bank holiday weekend, the Thursday of the Easter weekend and Christmas Eve in line with the application.

#### 4.2 INTERESTED PARTIES

The relevant representations relate to

- Noise and traffic
- Noise from the public house in particular the kitchen area
- Intoxicated patrons leaving the premises causing damage to garden pots, fencing, hedges, vehicles being keyed and urinating in gardens

- Noise from taxis outside the premises sounding their car horns as many as 10/15 times to gain attention.
- If hours of opening are extended it is felt that this may change the impact on who would frequent the premises in particular younger age groups that would further impact on the above issues.
- Noise nuisance from the bottle bank located near to the premises
- If the extension of hours is granted it is felt that it would be to the detriment of the surrounding residents
