1. PURPOSE OF REPORT

To recommend the adoption of a scheme of delegation for the purposes of the Licensing Act 2003.

2. RECOMMENDED: That the Regulatory Committee:-

- (1) adopt the Scheme of Delegation set out in the Appendix to this report;
- (2) determines that references to "Officers" in the Scheme of Delegation shall be deemed to refer to the Council Solicitor and any other officer authorised by the Council Solicitor; and
- (3) reserves the right to deal with any matter which is within the Scheme of Delegation if so recommended by the Council Solicitor.

3. SUPPORTING INFORMATION

- 3.1 The Licensing Act 2003 requires licensing committees to determine their own standing orders and schemes of delegation in the exercise of their functions under that Act. This requirement by-passes the normal Council standing orders which have to be approved by the Council.
- 3.2 The Appendix to this report sets out the proposed Scheme of Delegation. It mirrors the recommendations of the Statutory Guidance issued by the Department of Culture Media and Sport as well as the Council's Statement of Licensing Policy which was adopted in December.
- 3.3 The Council's Constitution contains the Committee's Scheme of Delegation for all matters outside of the Licensing Act 2003.

3.4 A separate Report deals with the setting-up of sub-committees of the Regulatory Committee and procedures to be adopted for hearing appeals.

4. POLICY IMPLICATIONS

The Scheme of Delegation will be a central policy document for the workings of the Committee with respect to the Licensing Act 2003.

5. OTHER IMPLICATIONS

There are no other implications arising out of this report.
