- All regulated entertainment shall be inaudible at the nearest noise sensitive property after 23.00 hrs
- The use of any outside area shall cease at 23.20 hrs
- No external speakers shall be used outside the building this will include any beer gardens or outside drinking area or car park.
- No further extensions to the hours for regulated entertainment service of alcohol or opening hours shall be permitted.
- All doors and windows shall be kept closed at all time when regulated entertainment is taking place.

- If premises opening hours extended this would cause even more noise and disturbance to local residents than currently endured.
- Longer hours would have an adverse effect on the quality of local residents lives.
- Local residents currently experience violence swearing in loud voices, vomiting, urinating, damage to property and a number of drink related road incidents from patrons leaving the premises.
- Local residents are aware that the current problems will still exist even if extension is not granted but if the extension is granted the above incidents will move from late evening into the early hours of the morning and totally destroy what little peace residents enjoy at present.
- Young underage drinkers are regularly served on the premises
- Devaluation of residential property in the area of the premises.
