These premises have been left empty for a considerable period of time. The first Provisional Application was made in February of 2003 and was eventually granted for 12 months on 19th November 2003. There have since been two extensions to this and a third request was refused at the final Sessions Court on 2nd November 2005. During this application it was stated that the new On Site date was to be 1st August 2006 for an opening on or around the 8th December 2006. Since that Hearing business press coverage reports that the plan for opening new premises in that year has been reduced from 38 to 13. To avoid a situation where town centre premises are being left unused for protracted periods of time without some progress being visible I seek to include these dates as conditional to issuing this licence.

Door Supervisors

Door Supervisors to be employed on nights when service of alcohol goes beyond midnight (Friday and Saturday). This location is in the centre of a group of three other late night venues, each being required to employ Door Staff at these times. Past experience of the area has shown that this is a necessity and any venue that was allowed to do otherwise would simply be targeted by the unruly elements who are unable to gain admission elsewhere.

Open containers CD10

No person in possession of a drink in a sealed or unsealed container shall be allowed to enter the premises except for the purposes of delivery.

CD12

No drink shall be removed from the premises in an unsealed container

Environmental Health

- The use of any outside area shall cease at 23:00 hours.
- Noise from any regulated entertainment (category B Films) shall be inaudible at the nearest noise sensitive property at any time.
- Extensions shall be permitted on the days as specified except where Burn's Night, Australia Day and the 4 Saint's days specified fall on a Friday or Saturday
