- Noise from any regulated entertainment (categories E & F) shall be monitored and a log of the monitoring shall be maintained for inspection by the Council.
- o The use of any outside area shall cease at 23.00 hrs.
- All doors and windows must be kept closed when any amplified music or voices are being played within the premises
- No external speakers shall be used outside the building this will include any beer gardens or outside drinking are or car park.

- Volume of music currently played at the premises is unbearable to local residents
