

#### 1. PURPOSE OF REPORT

To hold a hearing to consider an application for the review of a premises licence under Section 51 Licensing Act 2003. The Police have applied for the review which relates to the Prevention of Crime and Disorder licensing objective.

#### 2. RECOMMENDATION

That the Committee considers the Section 51 application

#### 3. SUPPORTING INFORMATION

- 3.1 An application has been made under section 51 Licensing Act 2003 ("the 2003 Act") to review the Premises Licence in relation to the above property.
- **3.2** This hearing is held in accordance with the 2003 Act and the Licensing Act 2003 (Hearings) Regulations 2005.
- **3.3** The procedure to be followed has been circulated to all parties and will be repeated at the beginning of the hearing.
- **3.4** The hearing is solely concerned with the Section 51 application.

#### 4 THE APPLICATION

- **4.1** An application for the review of the premises licence was received on 8 January 2010 from Cheshire Constabulary.
- 4.2 The premises licence permits regulated entertainment and the supply of alcohol and the hours the premises are open to the public are Sunday to Thursday 08.00 to 02.35 and Friday and Saturday 08.00 to 04.00
- 4.3 The Premises Licence holder is Padderborn Limited
- 4.4 The Designated Premises Supervisor is Robin Charles McLaughlin
- **4.5** The review was requested by Cheshire Constabulary on the following grounds:-

Please see the attached list of incidents (Appendix A) which have been recorded since August 2008. They indicate that the premises are not being operated safely and managed effectively.

Meetings have been held and Action Plans agreed (Appendix B) with the management in an attempt to address the concerns of the police, however, Mr. McLaughlin has either declined to cooperate with the police or has agreed to do certain things and then subsequently failed to do them.

The police are concerned that many of their concerns involve the poor conduct of the door supervisors employed at the premises and lack of CCTV coverage to the front of the premises where many of the incidents reported have taken place.

It is the view of the police that these premises are not currently being managed in a way that promotes the crime and disorder objective as required by the Licensing Act 2003 and that additional conditions are required to ensure that this condition is promoted at these premises.

### Appendix B

### **The Studio**

Meeting 11.55am Monday 20<sup>th</sup> July 2009 Widnes Police Station

Present: -

Robin McLaughlin – DPS Chris Carney – Licensing Enforcement Paul Draycott – Licensing Officer

PD thanked RM for attending. RM explained that he had been in hospital for the past 3½ months, but was willing to discuss any issues that the police might have. RM indicated that he was not prepared to agree to certain things – mainly regarding door supervisors wearing the police issue Hi-Vis jackets. He pointed out that there was no requirement either under the Licensing Act 2003 or the PSIA Act 2001. All his door supervisors were issued with black uniform which had a 'SECURITY' logo in 3" high letters on the front and rear. The door supervisors are all employed via an agency, Select.

PD outlined the advantages of wearing the Hi-Vis jackets and following a further discussion RM declined to accept the offer.

A discussion took place regarding CCTV at the premises, specifically covering the front entrance and the beer garden. CC advised that although there is a town centre camera at the top of the street it was largely ineffective because of street furniture that blocked the line of sight from that camera.

RM stated that he was happy to place two additional cameras, one in the beer garden and one covering the front entrance. He would arrange for the work to take place as soon as he could. (Action by RM)

RM also stated that he was going to see Enterprise Inns the next day to ask them if he could surrender the remainder of his 12 years lease. There is no guarantee that they will agree and even if they accepted the surrender it would mean that RM would still be managing the premises for at least 6-8 weeks. He also pointed out that Enterprise would want to keep the premises open, put in a caretaker manager and a new door company. This would very probably result in the premises being even more problematic than currently. (New manager, new door team, lack of knowledge, short term aims). (Action by RM to provide an update following the meeting.)

Everyone agreed the importance of remaining in regular contact to ensure that any issues from either side can be addressed at the earliest opportunity.
